Session 5: Designing Global, Distributed Governance Systems

Core Question: How can we develop a model and blueprint for a collaborative Internet Governance Ecosystem—what we think of as an upgrade to 21st century governance? Several sub-questions related to Internet Governance and, more importantly, distributed, global governance in general, must be considered, all from a perspective of designing innovative responses, including:

- ▶ How, when and who decides whether an issue requires global coordination or devolution?
- ▶ Who will, and how to, monitor adherence to principles of Internet governance in order to ensure accountability?
- ▶ How to accommodate new technologies and issues arising in a dynamic environment, affording stability without undermining innovation?
- ▶ How to coordinate across issue areas?
- ▶ What platforms are needed in order to operationalize legitimate forms of decision-making?
- ▶ How to ensure that the growing machine-to-machine Internet traffic is operated based on the same governance principles and frameworks of human use?

To frame the real-world problem workshop on Wednesday afternoon, Professor Giovanni Menduni – former innovation director for the City of Florence and professor at Politecnico di Milano – will introduce the challenge Florence faces in distributing the millions of tourists visiting the city each year. As it stands, the vast majority of tourism – and the unique stresses and economic activity tourism generates – is focused in a few specific cultural areas. The Network’s challenge will be to develop strategies for alleviating this concentration of tourism, which could serve to not only improve the experience of millions of tourists, but also increase economic activity throughout the city and enable better government services for Florentines.
