ADDITIONAL TERMS – PIX4Dinspect (ATPI) Pix4D General Terms and Conditions for Customers

This Additional Terms – PIX4Dinspect (the "ATPI") applies to You in case You have purchased through an Approved Source a Subscription to Our PIX4Dinspect Software.

The ATPI forms an integral part of and complements the Pix4D General Terms and Conditions for Customers (the "General Terms"), insofar as it sets forth specific terms and conditions applicable to Your Subscription to the PIX4Dinspect Software. It complements as well the Pix4D End-User License Agreement (the "EULA") given that a certain number of provisions contained herein concern the access and/or the use of PIX4Dinspect by You.

Unless otherwise defined herein, capitalized terms shall have the meaning set forth in the General Terms.

1 GENERAL

- 1.1 The PIX4Dinspect License is a Cloud Software License which grants You (and Your Authorized Users), against payment of the fees set forth in the Subscription Schedule or Invoice, the right to install, access, use and operate PIX4Dinspect within the limits of Your Consumption Allowance.
- 1.2 The PIX4Dinspect License gives You access to the PIX4Dscan App, a complementary mobile application designed to capture optimal data for further processing in PIX4Dinspect.

2 FEES

- 2.1 <u>Principle.</u> The PIX4Dinspect License fee is calculated in terms of the number of inspections that are uploaded on the Software (the "**Inspection Blocks**"). You may purchase an initial Inspection Block of a certain size corresponding to Your initial Consumption Allowance. You can freely choose the size of the Inspection Block You wish to purchase, knowing that the bigger the size of the Inspection Block, the higher the cost of the License, but the lower the price for a single Inspection Block unit.
- 2.2 <u>Price List</u>. The price list for PIX4Dinspect is available upon request to Our sales team using the Website contact form or via e-mail at sales@pix4d.com.

3 FAIR USE PRINCIPLE

Your use of PIX4Dinspect is subject to a fair use limit with regard to the size in PGP generated by the Input Content processed by You in the Software, which shall not exceed 15 PGP on a yearly basis(the "Fair Use Allowance") (i.e. 750 images of 20 megapixel each; a PGP being calculated as follows: number of images processed * image resolution [in MP] / 1000). Should You exceed the Fair Use Allowance, Section 3.2 (b) of the EULA applies.

4 SUBSCRIPTION TERM

- 4.1 <u>Term.</u> Unless agreed in writing by Us, You may only subscribe to PIX4Dinspect for a maximum Subscription term of 12 (twelve) months (the "**Subscription Term**"). The Subscription Term is non-renewable, but can be extended as described in Section 5.2 below.
- 4.2 <u>Use of the Inspection Blocks.</u> During the Subscription Term, You shall fully consume Your Consumption Allowance. If, at the end of the Subscription Term, You have not fully consumed Your Consumption Allowance, the balance of unused Inspection Blocks will be forfeited and no reimbursement will be applied.

5 ADDITIONAL PURCHASE OF INSPECTION BLOCKS AND EXTENDED SUBSCRIPTION TERM

- 5.1 Additional Purchase. If You have used Your Consumption Allowance in full before the end of the Subscription Term (or the Extended Subscription Term, as defined in Section 5.2(a) below) or if You simply wish to increase the size of Your Consumption Allowance, You may, at any time during the Subscription Term, purchase additional Inspection Blocks. You may do so by contacting Our sales team using the Website contact form or via e-mail at sales@pix4d.com. You may Order as many additional Inspection Blocks You wish, but only within the duration of the Subscription Term.
- 5.2 <u>Extended Subscription Term.</u> If Your additional purchase consists in an Inspection Block:
 - of an equivalent or greater size than the Inspection Block initially bought, then the Subscription Term will be extended for additional 12 (twelve) months from the date of the additional purchase (the "Extended Subscription Term");
 - (b) of a smaller size than the Inspection Block initially bought, then the Subscription Term will NOT be extended.
- 5.3 <u>Confirmation</u>. The Extended Subscription Term will only be applied further to Pix4D's written confirmation to You.
- 5.4 Payments. Additional purchases of Inspection Blocks must be paid in advance.

6 AUTO-REBUY

- 6.1 <u>Subscription</u>. You may separately subscribe to the auto-rebuy feature, which automatically recharges, during the Subscription Term, Your Consumption Allowance each time it expires with an additional Inspection Block of an equivalent size as the Inspection Block initially bought.
- 6.2 No Subscription Term Extension. The auto-rebuy feature does not extend the Subscription Term.
- 6.3 Opt-Out. You may cancel the auto-rebuy feature at any time during the Subscription Term, by contacting Pix4D through the Website contact form or through Pix4D's ticketing system.



7 MONTHLY STATEMENT

During the Subscription Term, Pix4D will provide You with a monthly statement showing the following information: Your active Subscriptions and their expiry date as well as Your total Consumption Allowance (Inspection Blocks) and the balance of unused Consumption Allowance (Inspection Blocks).

8 TRIAL

The Trial License Term for PIX4Dinspect is 30 (thirty) days.
